GIFT TOKEN OF NASHI-BO PREMIUM(なし坊プレミアム商品券)

10,000 yen gift certificate valued at 13,000 yen worth of shopping! 30% off the premium rate.

Shiroi City Executive Committee for premium goods (Shiroi Chamber of Commerce and Industry) will issue a "premium gift token" for a limited period (from July 1 (Wednesday), 2015 to Dec. 31 (Thursday), which will be accepted in various shops in Shiroi in order to promote consumption within the City.

The purchase of the gift token is via a booking application system by a reply-paid postcard. The application postcard should be postmarked on or before June 12 (Friday); the sooner the better.

"Gift token of Nashi-bo premium" is for a total of 13,000 yen, comprising 6 coupons of 1,000 yen for common use in large and middle/small-sized shops, and 7 coupons of 1,000 yen for exclusive use in middle/small-sized shops, and it will be sold at the price of 10,000 yen.

To buy these gift tokens, a prior booking application is required.

* Exclusive coupons for middle/small-sized shops cannot be used in large shops. Common coupons, however, for the large and middle/small-sized shops can be used in all shops.

Process for applications

Deadline for Booking Applications: June 12 (Friday). Postmark valid on or before the day.

Eligible persons: Heads of household living in Shiroi

How to apply: By rely-paid postcard addressed to $\overline{}$ 270-1422 Fuku 1458, Shiroi city. Attention: Shiroi city Shoko-kai (Shiroi Chamber of Commerce and Industry) "Nashi-bo Premium Gift Token"

*Applications are limited to one postcard per family. Applications for plural tokens or applications received from persons other than the head of a household will be invalid.

Drawing lot: Late in June

Eligible applicants will be notified by a reply card from the Shiroi Executive Committee, stating "Nashi-bo Premium Gift Token". The card will show the number of possible coupons for purchase and the names of the shops were the coupons can be exchanged, etc. The total number of gift tokens to be issued is 25,000 coupons. If the number of applicants exceeds that of issue, successful applicants will be decided by lottery.

Sale exchanging period: July 1 (Wednesday) through July 14 (Tuesday)

The reply card stating "Nashi-bo Premium Gift Token" is available to be exchanged for a set of coupons upon cash payment at the designated shops. A set of coupon costs 10,000 yen. If the reply card is lost, you will not be able to buy the gift tokens.

The term of validity: July 1 (Wednesday) through Dec. 31 (Thursday) 2015

The coupons cannot be used after the expiry date. Make sure to purchase goods within the date of validity.

MAYOR FUMIO IZAWA'S FIRST ATTENDANCE AT THE CITY HALL

(伊澤史夫市長初登庁)

Mayor Izawa will exert himself to the utmost to realize "a happy city in which to have lived, or wish to continue to live".

Mayor Izawa won the election as Shiroi city mayor, which was held on April 26, and made his first attendance at the city hall on April 28.

Mayor Izawa stated in front of citizens, members of the city assembly and city staff that the city is becoming less populated with children and more of a society for persons of advanced age, and it is expected that the population will decrease over five years. To manage this situation, Mayor Izawa wishes to build up the city's foundation, taking all possible measures for sustainable development and to hand over a healthy city to our children and grandchildren.

In order to fulfill citizens' expectations, the Mayor said that he would do his best together with many citizens, the city administration and city assembly, aiming for an open Shiroi administration and realizing "a happy city in which to have lived, and wish to continue to live".

REQUIRED TO SUBMIT A NOTICE OF PRESENT STATUS FOR CHILD SUPPORT

ALLOWANCE (児童手当の現況届を発送します)

A notice form of present status for child support allowance will be sent to recipients in the first half of June. Please complete the form and submit it with the necessary documents.

The notice is the document that the City requires to confirm whether or not a recipient of the allowance is still eligible according to income for FY2015 and the children's status on June 1st. The income limit according to the number of dependents is shown in the chart below. Child support

allowance will be provided in June, October, and December, 3 times a year. Without submitting the notice form of present status, you may be unable to receive the allowance after June 2015.

"EXTRAORDINARY SPECIAL ALLOWANCE" WILL BE SUBSIDIZED FOR CHILD-REARING

FAMILIES (「子育て世帯臨時特例給付金」が支給されます)

Due to the 8% increase in consumption tax, "child-rearing families will receive an extraordinary special allowance".

In this year's application form, there is a column for "child-rearing family special allowance" in addition to the "child allowance/extraordinary notice for present status". When you receive an

application form from the City, please complete the application form and submit it to Child Support Section by the deadline date.

[Allowance recipient]

Recipients of child allowance for the month of June 2015 (except special allowance).

* The special allowance recipient is the person who earns a salary more than the limit of income for child allowance in 2014 (persons who receive 5,000 yen per month per child)

[Allowance]

3,000 yen per child who will receive child allowance in June 2015.

* Allowance for 2015 is for children who get an extraordinary welfare allowance, and children of guardians in the public livelihood allowance system, as well.

[Application term] June 1 (Mon.) through December 1 (Tues.) 2015

[Allowance starting date] After October 2015

[How to apply] Mail to or visit the *Kosodate-Shien-ka* or Child Care Support Section by the enclosed reply envelope

* Public servants will receive an application form for the "child-rearing extraordinary special allowance" to be delivered from their working office. Please complete the form and submit it together with necessary papers to the Child-support Section within the application deadline.

[Notice] For those people who have got out of danger due to spousal violation (domestic violence, or DV), and live in Shiroi city without transference of their resident registration from the previous municipality, they may make an application for the allowance to Shiroi City, if "a certain condition" is met. Please visit the city office for consultation.

Portion Subsidy for Private Kindergarten Expenses (私立幼稚園就園獎 励補助金)

Children of 3, 4 or 5 years of age, who go to a certified private kindergarten, a portion of the expenses will be subsidized according to the parents' income. The subsidy amount is shown as follows. (See tables 1 and 2). Persons who meet both conditions in table 1 and 2, will receive a higher subsidy.

Eligibility: Parents of children who go to a certified private kindergarten (born from Apr. 2nd, 2009 to Apr. 1st, 2012), and live in Shiroi City.

- When a 3-year old child (born from Apr. 2nd, 2012 to Apr. 1st, 2013) enters kindergarten in the middle of the year before April next year, the subsidy will be available.
- When more than 2 persons in a family have income, the income tax of parents and the main supporter will be added.
- City tax in proportion to its income means the amount before deduction of dividends, foreign taxes, donations, house loans.
- Standard amount A means 34,500 yen plus the following ① or ②
 - ① Multiply 21,300 yen by the number of dependents under 16 years old
 - ② Multiply 11.100 yen by the number of dependents from 16 years and under 19 years old
- Standard amount B means 171,600 yen plus the following ① or ②

- ① Multiply 19,800 yen by the number of dependents under 16 years old
- ② Multiply 7,200 yen by the number of dependents from 16 years and under 19 years old
- The maximum subsidy for the 3rd child in a family that has more than 3 children going to kindergarten at the same time, is 308,000 yen. 4

Applications: Fill in the form "Report for reduction and exemption of kindergarten expenses", delivered at each kindergarten, and submit it to your child's kindergarten.
