#### LET'S TAKE PREVENTIVE SPECIFIC HEALTH CHECK-UP FOR LIVELIHOOD RELATED

DISEASES (生活習慣病の予防のために特定健康診査を受診しましょう)

Shiroi city is conducting specific health check-ups for people who are aged forty years and over, and who have joined the National Health Insurance (herein after referred to as NHI). Livelihood related diseases such as high blood pressure and diabetes don't show particular symptoms at an early stage. The diseases might be getting worse by the time the symptoms appear. Why not receive health check-ups and know your health condition, and take advantage of prevention and improvement for livelihood related disease?

#### ♦Specific health check-ups

Specific check-ups are carried out for the purpose of detecting livelihoodrelated diseases. These check-ups are free of charge. For those who may have a high risk of disease, the city's health nurse or dietician will give those people advice on livelihood improvement at the check-up place. People at risk of livelihood-related illnesses are recommended positively participate.

For those who moved to Shiroi after April 29, 2016, or changed from other public health insurance policies, and who desire to take the check-up, please apply directly to Hoken Nenkin-ka or the Insurance and Pension Section.

For specific health check-ups for persons insured under other health insurance policies, please contact the corresponding health insurer.

#### **♦**Check-up details

- · Basic items: interview (medicines being taken, smoking habits, etc.), body measurements (height, weight, BMI (body mass index), belly), examination, blood pressure, blood check (liver & kidney function, blood sugar, cholesterol levels), urine analysis
- Detailed items:(the doctor will decide upon the necessity of certain tests) electrocardiogram, funduscopy (eye examination) and anemia (red blood cell count) check
- Things to bring: NHI certificate, questionnaire sheet, slippers (not necessary in Hoken-Fukushi center)

#### ◆Partial Subsidy for Body and Brain Medical Check-up Expenses

# For Members of Public Medical Care Insurance (PMCI) for the Aged (persons aged over 75 years, partial subsidy expenses to be granted, as well

The city will subsidy partial expenses for a body check-up (once a year) and brain check-up (once every two years) for those who are aged forty years or over, and who have joined the NHI for more than one year without any non-payment of the NHI tax. Anyone who desires these checks, are asked to apply to the Insurance & Pension Section in advance without fail. Those who have already taken the specified health check-ups, cannot receive a subsidy retrospectively.

Members of PMCI aged over 75 years will get a partial subsidy, as well.

#### NOTICE FOR PREMIUM OF PUBLIC NURSING CARE INSURANCE (PNCI) (介護保険料のお知らせ)

PNCI is a system to provide mutual support for everyone to ensure a life without anxiety, and to receive care or financial assistance in times of need. Revenue sources for PNCI include the premiums from insured persons, and the state, prefecture, cities' public expenses, and the users' burdens.

#### Payment for the nursing insurance premium

#### **◆**The Primary Insured Person

The premium payment begins in the month following a person's 65<sup>th</sup> birthday and is paid to the city. The premium rate has several classes depending on the previous year's income and family situation. It will be decided on an individual basis.

#### [Payment method]

There are two types of payment method available. One is a subtraction from a pension, called the special payment, and the other is paid from a person's bank account, called the ordinary payment.

#### ♦ Special payment from pension

For pensioners who receive an annual income (either one of the old-age (retirement), disabled or survivor's pensions) of 180,000 yen or over, the premium for the nursing insurance will be subtracted from each periodical pension.

\*The premiums for the months of April and June are temporary payments, which are for the same amount as the premium for February of the previous year. For the months of August, October, December and the following February, the amount to be paid will be calculated based on the amount already paid as a temporary payment, subtracted from the newly decided premium for 2016. The balance from this calculation is then divided by four, which will be paid for the remainder of FY2016.

#### ♦Ordinary payment from your bank account

Persons corresponding to one of the following  $\bigcirc \sim \bigcirc$ , are requested to pay by the statement of payment which the city will mail to you on Friday July 15.

- ① Persons who receive an annual pension of less than 180,000 yen from the old-age, retirement, disabled or survivor's pension
- ② During the FY2016, a person who reaches the age of 65 years (No. l insured)
- ③ A person who moved into the Shiroi city from another municipality
- ④ A person whose premium class has changed during the year

%In cases of the above  $@\sim @$ , an ordinary payment is applied until the special payment method starts

Places to pay: the city office, financial institutions, or convenience stores

#### **♦**The Secondary Insured Person

Care premiums until 64 years of age will be paid to the medical institute insurer starting from the month following a person's 40<sup>th</sup> birthday. Please contact your current medical institute insurer for more details.

#### Early Consultation is Recommended

If, without any special reason, your care insurance premium falls into arrears, the insurance benefit will be restricted according to the period of arrears. In situations where there is a special reason for delaying payment, you may be entitled to a grace or divided payment upon application. Your early consultation is appreciated.

#### Payment of One's Own Expenses

The care charge is 10 percent or 20 percent of the total medical expenses, depending on the situation for taxes imposed or income amount. The valid term is one year from August 1 to the end of July next year. An insured certificate will be mailed to the No. 1 insured aged 65 years and over who has been designated as requiring support- or nursing care-needed classes at the end of July from the city. When you need assistance, please show this certificate to the enterprises together with the PNCI certificate.

## NATIONAL HEALTH INSURANCE (NHI) & PUBLIC MEDICAL CARE INSURANCE FOR PERSONS AGED

75 YEARS AND OVER (PMCI) 国民健康保険と後期高齢者医療

#### ♦New Insurance certificates to be mailed

Current in-use certificates for NHI and public medical care insurances (**PMCI**) for the aged (persons aged 75 years or older) will expire on Sunday, July 31, 2016.

The new insurance certificates to be used from Monday, August 1 will be mailed at the end of July by registered mail (except to some areas).

When you receive the new certificates, please make sure of the address, name, birth date, etc. for family members as well. A certificate will be mailed for each member of the insured. If you find any details incorrect, please contact the Hoken Nenkin-ka or Insurance and Pension Section (**I&PS**).

The old (invalid) certificate may be returned to either I&PS or each Center, or disposed of by cutting it into pieces after August 1 (Mon.)

## National Health Insurance (NHI) 国民健康保険

#### ◆Renewal of NHI insured certificate combined with the aged health certificate

The aged certificate (for persons between 70 and 74 years old) and the insured certificate have been combined into one

The payment rate at the desk of medical institutes is 10 percent of the charge for persons born before April 1, 1944; 20 percent for persons born after April 2, 1944 and 30 percent for persons who earn a similar income amount to a current worker,\*

These ratios are decided on the basis of information as of August 1 each year. Please ensure your ratio is correct as shown at the bottom on the right side of your new certificate.

\*\*"Similar income amount to current worker" means a person who is aged between 70 years and 74 of NHI member, and whose taxable income for resident tax in FY2016 is over 1.45 million yen (including for members of the same family).

- ◆There may be cases for a person whose rate is 30 percent being decreased to 10 or 20 percent upon application. For those aged between 70 and 74 years, the payment rate has been determined as 30 percent of medical charges (including family members), which is the same as for current workers. If one of the following conditions corresponds, the ratio will be decreased to 10 or 20 percent upon application.
- ① Person is a NHI member, living alone, aged 70 years or over with an annual income of less than 3.83 million yen
- ② More than two NHI members, living together, aged 70 years or over, with a total annual income of less than 5.2 million yen
- ③ Person is a NHI member, aged 70 years or over, (not corresponding to ① above), and living with another person (moved from of PMCI for aged 75 years or over) with a total annual income of less than 5.2 million yen.

# ◆For persons who have approved certificates for the applicable limited amount and receive a reduction in standard payment amount

Approved certificate holders may receive a reduction in medical expenses at the desk of a medical institute up to the limited amount, depending on income, when the amount of medical expenses is high. The current approved certificate is valid until Sunday, July 31, 2016.

Persons who want to continue after Monday, August 1, are required to renew their certificates. Please visit I&PS for renewal, bringing your current approved certificate, Inkan (seal) and a health insurance certificate.

#### ◆Please don't forget application for 'joining or withdrawal' to/from NHI.

Within 14 days a procedure is necessary for joining a new enterprise's insurance or withdrawal from the current health insurance. When a nominated head of family or address changes, an application is also necessary.

There are two choices upon retirement; one is to continue in the current health insurance system (voluntary continuation) and the other is to join the NHI system.

For a voluntary continuation, you are requested to ask the current enterprise for more details.

## Public Medical Care Insurance for persons Aged 75 years or over (PMCI) (後期高齢者医療)

#### **◆**Payment ratios at the desk of medical institutes

There are two ratios, 10 percent and 30 percent (30 percent is in cases where the income amount is the same as for current workers). These ratios are decided on August 1 every year, and are shown at the bottom on the right hand side of the certificate.

\* The same income as current workers is more than 1.45 million yen of taxable income for FY2016 resident tax (including family members)

#### ◆There may be cases of a person whose rate is 30 percent having the rate reduced to 10 percent.

Persons who have been identified as paying 30 percent of medical charges, can have the rate reduced to 10 percent (upon application), in the event of one of the following conditions:

- ① PMCI insured, living alone with annual income of less than 3.83 million yen
- ② More than two PMCI members, living together with total annual income of less than 5.2 million yen
- ③ PMCI insured, living alone (not corresponding to ① above), but person aged between 70 and 74 years living in the family, and their total annual income is less than 5.2 million yen

# ◆ For persons who have approved certificates for the applicable limited amount and a reduction of the standard payment amount

Approved certificate holders may get a reduction in medical expenses at the desk of a medical institution up to the limited amount, depending on income, when the amount of medical expenses is high. The current approved certificate is valid until Sunday, July 31, 2016.  $\times$  (this column is the same as the one in the previous page)

The person who has the approved certificate valid between August 1, 2015 and July 31, 2016, and whose family members are all resident tax exempted after August 1, 2016, there is no need to apply for a renewal. A renewed

certificate will be mailed together with a new health certificate.

If all family members are resident tax exempted, and desire a newly approved certificate, please visit *Hoken Nenkin-ka* or Insurance & Pension Section bringing your health certificate and *Inkan* or seal.

## National Health Insurance (NHI) Tax and Premium for Public Medical Care Insurance (PMCI) for the Aged

(those aged over 75 years) (国民健康保険税と後期高齢者医療保険料)

The systems for the NHI and PMCI are in the "spirit of mutual cooperation", with participants paying the tax and premium according to their income amount, and it is used for medical expenses.

#### ◆Payment notices for NHI tax and PMCI premium to be mailed

#### [Ordinary Payment]

For those who pay by payment notice or automatic withdrawal from a bank account, notifications will be mailed by the middle of July.

The dates of payment are divided into eight periods, at the end of each month from July 2016 until February, next year. Please pay by the due date to the financial institution without delay in order to maintain operational stability. Please confirm your account balance at the bank by the payment date to ensure payment can be withdrawn from the bank.

#### [Special Payment]

For those who receive a public pension of more than 180,000 yen annually, the premium will be subtracted from the pension. Special payment notices will be mailed by the end of July, so please check and confirm the amount.

#### [Payment by both special payment and ordinary payment]

Notices of tax or premium payment will be mailed in mid-July for persons making special payments starting in October.

#### **♦**Tax payer

#### [National Health Insurance]

Tax payers are the head of the family on their resident's card. Tax is calculated by family based on each person's income and the number of family members. If a head of family is a member of another insurance provider (enterprise's social insurance, etc.), the family head remains responsible for payment.

#### [Public medical care insurance for the elderly]

For tax payers who are members of PMCI for the elderly, which is different from the NHI, each insured is the tax payer.

#### ◆Calculation of NHI tax and PMCI premium

#### [For persons who become 75 years old during FY 2016]

When a person becomes 75 years old during FY2016, they will be transferred to PMCI system automatically, and their PMCI premium is calculated in advance before their birth month so as to avoid duplicating the NHI tax. The notice of payment will be mailed after the person becomes 75 years old.

#### [For persons who become 40 years old during FY2016]

When persons become 40 years old during FY2016, their Nursing care insurance membership (No. 2 insured) starts, and their NHI tax for the nursing care insurance commences. Corresponding persons will be notified. After reaching 40 years old, the tax is added and a notice will be mailed.

#### Persons Moving into Shiroi on/after January 2

For such persons Shiroi city will notify persons via a change notice, after making inquiries at their previous municipal offices.

In mid-July a notice of payment stating the calculation of family amounts per capita and equality in case of NHI, and for PMCI, a notice for per capita amount only will be mailed from the city.

#### **◆**Early consultation is recommended for late tax payments

Persons who can't pay tax or premiums within the due time for some reason, are requested to contact the city office for consultation about divided payments, etc.

If suffering from disaster etc., a tax exemption may be granted. Please consult the city office for more details. <u>Applications and inquiries contact:</u> *Hoken Nenkin-ka* or Insurance & Pension Section Tel. 492-1111 ext. 3171/3

## **Don't Forget Tax Payment** (納存を禁れずに)

Monday, August 1 is the deadline for the following city taxes, etc.

- · Real estate tax and city planning tax (2<sup>nd</sup> term)
- · National health insurance tax (1st term)
- · Public nursing care insurance premium (1st term)
- · Public medical care insurance premium for the elderly above 75 years (1st term)

Let's pay the city taxes, etc. within the due date (If not paid, money in arrears will be imposed)

Automatic payment withdrawn from your bank account is a convenient system. City taxes etc. may also be paid at convenience stores, if it is within the due time (except public medical care insurance for the elderly)


Mikiko Ando, coming from Shiroi city, will represent Japan for weight lifting athlete at the Rio de Janeiro Olympic Games

#### EXEMPTION OF NATIONAL PENSION PREMIUM

こくみんねんきんほけんりょうめんじょしんせい (国民年金保険料免除申請)

Everyone who reaches the age of 20 years, even if they are students, must be insured by the National pension. If the pension premium is not paid, if you are injured or die due to an accident, the disability pension or survivor's pension will not be paid.

Please use the system of "Exemption of pension premium" and "Young people's (under 30 years old) delay of payment" if it's difficult to afford the premium. You can apply for them retroactively for 2 years and one month.

#### **★** Exemption of pension premium

For those whose income including of their spouse and the head of a household is under the limit income, the pension premium will be exempted totally or partially (three quarters, half, one quarter) after making an application. The approval period will be from July to June next year.

#### \* Postponement of payment of premium

For those whose income including of their spouse is under the limit of income, the pension premium will be exempt after making an application. This system will be expanded for those under 50 years old from July 2016. (Until June for those under 30 years old). The approval period will be from July to June next year.

#### **★** Postponement of payment of premium for students

Students and their spouse who cannot afford to pay may be exempt from payment.

Eligibility: Students at university (graduate university), college, high school, technical school, vocational school (more than one year curriculums). Approval period is from April to March next year.

**★Things necessary for the application**: Inkan (family seal), pension handbook, "employment insurance recipient qualified certification" or "employment insurance unemployed person certificate" for unemployed, or student ID card copy.


