EARLY APPLICATION FOR INCOME TAX RETURNS IS PREFERABLE

(所得税の還付申告は早めに)

Declarations for the final income tax returns for 2012 will be accepted from Monday, February 18 until Friday, March 15. Shiroi city will conduct free consultations and self-writing guidance for citizens seeking a refund on their paid income tax for special deductions such as a housing loan etc., and for medical expenses.

• People who may apply for a refund

An employment income earner may apply for a refund as follows:

[Special deduction of housing loan etc.]

Those who bought a new or used house, or an old house that was renovated with funding from a housing loan, and who meet the following requirements, may get a special deduction for their housing loan etc.

For a new house: following ① to ⑤

For a used house: following ① to ⑥

- ① He/she moved into a house within six months after purchase, and is still living in the house
- 2 His/her total annual income is less than thirty million yen
- ③ The term of loan repayment is more than ten years, payment is via monthly installments, and the year-end balance still remains at the end of 2012
- ④ A house has floor space of more than 50 m2, and more than a half of the floor space is for the exclusive use of living
- (5) He/she doesn't receive any special exemption for a property transference income within two years of the occupancy
- (6) The house before its purchase had been built within 20 years (within 25 years in case of the fire-proof building)

[Deduction of medical expenses]

If medical expenses were paid for yourself and/or your family due to illness or injury, an income tax deduction will be granted at a certain amount.

Amount of deduction: Medical expenses paid in 2012 minus an amount covered by insurance, and further minus 100,000 yen (in case the total income is less than two million yen, 5% of the income)

• Pensioners do not need to make a declaration

For pensioners, if your annual income is less than four million yen, and other income amounts are less than two hundred thousand yen, an income tax declaration is not necessary. However, those who would like to get an income tax return, may apply for a refund.

Further, those who would like to get a deduction for any life insurance commission which is not mentioned on "a certificate of the tax deducted at source for public pension etc.", need to declare to the city and prefectural resident tax office.

◆ Free consultation/self-writing guidance

The city's assistants will help tax payers write a declaration form by PC free of charge and submit it, and provide "self-writing guidance" at the city office on the following dates. On these days you may also submit forms that you have already prepared.

The table below shows the necessary papers to bring etc., and dates of "free consultation" and "self-writing guidance".

Necessary things to bring for Final Tax Return Declaration

Inkan or seal, writing tools, calculating machine, papers to show your 2012 income amount (Gensen Choshu-hyo or tax deducted certificate for salary earned and pension) and deducted amount, applicant name's passbook of financial institute, etc.

Depending on the different declarations, different papers need to be prepared as follows.

Main papers to show deductions: spouse's income amount, deducted certificates (original) for life insurance and earthquake insurance commission, deducted certificate for National Pension insurance, "notice of paid amount" issued by the city, and a copy of the handicapped book or \lceil deduction certificate for the handicapped \rfloor

Notice from the Narita Tax Office

[Writing the final tax declaration and venue of submission]

The Narita Tax Office will hold writing consultations for final income tax declarations for 2012, such as taxes for income, donations, and individual consumption. The desk opens in the Aeon hall (2F floor), Narita Aeon mall (Narita city) on the following schedule.

- * There will be no tax payment desk in the hall. The tax paid certificate will not be issued there.
- During this period, the Narita Tax Office will not provide any writing assistance or accept any final tax declaration papers.

The Hall working date: On week days: Friday, February 1 - Friday, March 15

9:00 – 4 p.m.

On Sundays; February 24, March 3 from 9:00 a.m. – 4:00 p.m.

X Consultation and receiving desk opens until 5 p.m.

e-Tax is a convenient way to make a declaration

- The National Tax Agency's home page provides a "Final tax return making corner". When using it, you may submit your data through the internet.
- When you submit your data for the 2012 income tax paper by e-Tax within the period of time, you may receive a maximum deduction of three thousand yen from your income tax.

XYou may get this deduction only once during 2007 and 2012 by utilizing e-Tax

- Using this system, you may omit submitting necessary receipts of medical expenses or a certificate of tax deduction
- X You must keep these necessary papers for five years in case the Tax Office requests to see them at a later date.
- You may get a refund of income tax earlier than the normal procedure if you use e-Tax.

• From the year 2012, you may utilize e-Tax for tax declarations of donations

DETECTION OF RADIOACTIVE SUBSTANCE FOR AGRICULTURAL PRODUCTS

(農産物の放射性物質検査)

To secure the safety of agricultural products, Shiroi city and Chiba prefecture conducted detection of radioactive substances on January 10 and 11.

The result of the examination is that radioactive substances were "not detected" on any of the tested articles.

The City and prefecture's examinations were as follows:

Shiroi city's products: strawberry, komatsuna (a leafy green vegetable), tarsai (Chinese vegetable), carrot and hakusai (Chinese cabbage)

Chiba prefecture's product: leek

* "Not detected" means that the radioactive substance doesn't exist, or the figure is less than the minimum limit that the measuring instrument can detect. The minimum limit detected varies, depending on several conditions such as the instrument, volume, density, etc. With the city's instrument, total of cesium 134/137 are about 23 becquerels per kg. The standard value of radioactive substance for common food is 100 becquerels per kg.

The NASHI BOY FAMILY was born in 1995 (Heisei 7) as an image character of Nashi pear, a special product of Shiroi city, and it was named by public advertisement. The Family has 6 members - "Nashi Boy", "Kaori", "Yutaka", "Sachi", "Chojuro", and "Taka".

They participate in many activities that promote Nashi pears and other products, to improve Shiroi city's image.

The City has produced several items and special articles to popularize the Nashi Boy Family.

[Nashi Boy goods]

Original name card (mount) Available at Kikaku-seisaku ka(Planning and Policy Section) with the design of "Nashi Boy", "Nashi Boy Family", and Nashi boy points out the location of Shiroi City on the map for those who don't know where Shiroi is. (100 card in a box ¥ 250)

Nashi Boy Family fan 15 different kinds of design are available, which encourages the idea of saving energy. The paper patterns can be downloaded from the city website.

Nashi Boy Family paper craft To commemorate of city's population reaching 60,000 in 2009, 6 kinds of design for each member of the family are available on the city website. When small children make it, a parent's supervision is required to ensure children don't get hurt with a cutter or scissors.

[Use and application of the "Nashi Boy Mark"]

The "Nashi Boy Family" has become very popular among children and adults. The City encourages use of the Nashi Boy mark to make it more familiar to people. When you use the mark, please apply for permission via the "Nashi Boy Mark" usage application form (available on the city website) at Planning and Policy Section.

The "Nashi Boy Family" page is updated by Nashi Boy slowly and calmly. The pages introduce the Nashi Boy Family, and "Nashi boy and Kaori report" with photos.
