Holiday of February - 2/11 Kenkokukinen no Hi (National Foundation Day)

In 1873, the Meiji government designated Feb 11 as Empire Day based on the myth that the first emperor, Emperor Jinmu took the throne on Feb 11, 660BC. The Empire Day was abolished under the GHQ order on 1948, but later National Foundation Day was introduced on 1966.

ACCEPTANCE OF DECLARATION FOR 2018 YEAR OF CITY/PREFECTURAL TAXES, AND FINAL RETURNS FOR INCOME TAX

(「市民税・県民税の申告」と「所得税の確定申告」の受け付け)

Shiroi city will conduct the "Acceptance of Declaration", "Guidance of Self-Writing/Individual Consultation" and "Free Consultation by the Tax Accountant Society" from February 18 (Mon) until March 15 (Fri).

Distribution of the Declaration form at the city office and branch office will be from the last ten days of January.

Those who need to declare

Citizens living in Shiroi (on Jan. 1st, 2019) and corresponding to one of the following conditions during the year of 2018.

[City/Prefectural Tax]

- Those who received employment income only, but their employer has not reported the payment statement (a certificate of tax deducted) to the Shiroi City Office.
- Those who don't need to make a declaration of income tax, but who would like to claim various deductions such as a life insurance premium, etc.
- Those who received a handicapped person's pension or survivor's pension, but received no other income.
- Those who had no income and were not anyone's dependent.
- Those who are dependent on a relative who is a tax payer living in another city.

- The spouse of those who had an income of 380,000 yen or less per year living at the same address.
- * People are still required to submit a city/prefectural resident tax declaration if they have an income.

[Income Tax]

♦Persons who have business income or real estate income:

Those who received the whole amount of their income in 2018, which exceeded their total income deductions for items such as basic deductions and dependent deductions, etc.

Persons who are not required to submit an income tax declaration are still required to submit a city/prefectural resident tax declaration.

◆Persons who received an employment income:

- · Those who received an employment income exceeding 20 million yen per year
- · Those who received more than 200 thousand yen per year of private income other than employment income
- · Those who received incomes from more than two different employers
- Those who had income tax withheld, want an income tax refund for medical bill deductions and/or housing loan deductions, etc.
- · Those who retired in 2018, and had no year-end tax adjustment

♦Persons who made a donation to their hometown and require a donation deduction;

Persons who made a donation to their hometown from January 1 till December 31, 2018

** Those who made a donation to 5 groups or less, applying one stop exception, and who received an employment income that does not require an income tax declaration can receive a tax deduction by submitting "a special application" to the government detailing the donations made.

Things to bring for declaration

- · My-number card, a notice card, or a document with My-number written and a driver's license (the copy needs to be attached)
- · Inkan or Seal,
- · writing materials,
- · a calculator
- Document showing a whole income for 2018 (salary payment or certificate of tax deducted at source for pension, etc.)
- · Your account numbers for your financial institution (bank or post office)
- The copy of FY2017 declaration that shows the amount of deduction for those who made a declaration last year
- · A document, etc. that shows a deducted amount, such as the following:
 - Certificate which shows deduction for premium on National Pension, or a copy of payment receipt
 - Receipt which shows the amount paid such as National health insurance premium, Nursing care premium, Medical insurance premium for senior citizens
 - Deduction certificate for a premium for life insurance or earthquake insurance
 - > The detailed statement of the medical expenses deduction.
 - A copy of physically handicapped book

A document for spouse's income amount

If a person doesn't have a physically handicapped note, if he/she is 65 years old or over, and has been approved as requiring necessary support care, he/she may be considered as a person who is a deducted person, and is encouraged to consult *Koreisha Fukushi-ka* or the Elderly Welfare Section. A document necessary to declare the special deduction for housing loan for the first time

- · A detailed statement of housing loan special deduction
- · Certificate of year-end balance
- Document of house and land sales contract
- House and land registration certificate

Pensioners do not need to make a declaration

Among pensioners, those who received a public pension income of less than 4 million yen per year, and received less than 200 thousand yen of other income, are not required to make a final declaration of income tax, but may submit an application for the final income tax return.

Persons who don't need to declare their income tax, who want to receive a deduction of life insurance premiums, etc. which are not listed on "the tax deduction certificate", are requested to declare the city/prefectural resident tax.

"e-Tax" makes it easy to make a declaration

Declaration made by PC at the city declaration consultation should be submitted online. You can make a declaration with ID, password registration and send it online.

Besides the things to bring for the declaration, prepare your password that contains 8 to 50 figures with alphabet lower case letters and numbers.

"Free Consultation" "Self-writing Guidance Class" to be Held

Notes;

- ① If you prepare documents by personal computer (PC) (Accountant Society), staff will assist. Final documents may be submitted (or by mail)
 - Distribution of declaration documents will not be available.
- ② City staff will assist self-writing, and the final documents may be submitted.
- * For both ① and ② as to 'Blue Return' declaration for income tax, transfer income, consumption tax, donation tax, etc, the city will only accept the form. For a consultation please contact Tax Office.
- According to the participant numbers, reception may be closed early.

"Medical expenses notice" can be used to declare a medical expenses deduction

The attachment of the detailed statement of the medical expenses subtraction is necessary in substitution for the presentation of the receipt. When you make a declaration, prepare the detailed statement of the medical expenses.

- X You need to keep the receipt of medical expenses for 5 years.
- * If you attach a medical expenses notice sent from the insurer, you don't have to make the notice.

Medical expenses notice forms are different according to each insurer, and some notices may not be used for the declaration. Please confirm with the insurer.

When your actual payment is not the same amount as the written one on the notice, you need to correct the expenses on the declaration.

Make sure to keep "copied receipts" for large amounts of medical expenses (高額な医療費を負担した人は、必ず「領収書のコピー」を)

If you paid a large amount (where the monthly total amount exceeds a family's fixed limit) for the city's National Health Insurance, the city will make a refund for 'large medical expenses' upon your application. For the application procedure, a receipt (or copy) of medical expenses must be attached. Take care when applying for a tax declaration. Keep the copy of the receipt of medical expenses to receive a refund for 'large medical expenses'.

The city will notify a corresponding person as to the refund procedure two or three months after the medical consultation. For example: the city's notification will be sent at the end of January for a consultation in November; in February, for consultations at the end of December.

[Notice from Narita Tax Office] (成面税務署からのお知らむ)

Writing a declaration form and submission

Narita Tax Office (*Narita Zeimusho*) will open a meeting place to write and submit 2018 taxes for income, special restoration, consumption of private business, local consumption, and donations. However, consultation of inheritance tax, payment of the state tax, and application and issue of paid tax certificates will not be conducted.

Narita tax office will not provide an open writing space.

Until 31st (Thu) Depreciable or Fixed Assets Tax Declaration

(償却資産(固定資産税)の申告)

What are depreciable assets?

They are business assets such as construction substances, machinery, vehicles, tools and equipment (not including land or houses) for people who run factories, shops or agriculture.

Please submit the application form if you possess any depreciable assets in the city and if you are a citizen as of January 1, 2019.

The due date: January 31 (Thu)

* The application form will be distributed at *Kazei-k*a or Taxation Section in the city office. It can also be sent to you upon request.

Would you like to make your My Number Card (Individual Number Card)? (マイナンバーカード (個人番号カード)を作りませんか)

My Number Card is an official identity card, made of plastic with an IC chip, that has the bearer's photo, name, address, date of birth, and gender. With your My Number Card, you can print a copy of your certificate of residence and certificate of registered seal using the multi-copy machine in convenience stores (from 6:30 am to 11:00 pm excluding December 29th to January 3rd. The user's electronic certificate must be installed). In addition, it can be used for final tax return application using an exclusive use card reader (signature electronic certificate must be installed).

Application Procedure

By Mail

Fill the necessary items in the "Individual Card Issuance Application Form" sent with "Notification Card", paste your picture and mail it using the given envelope.

By Computer

Take a photo of your face using a digital camera and apply through the website (URL: https://net.kojinbango-card.go.jp). Please enter the necessary information, attach a photo, and submit.

* When applying, the ID specified in the individual number card issuance application form is required.

By Smartphone

Take a photo with your smartphone and read the QR code of the individual number card issuance application form sent with the notification card. Please enter the necessary information on the application website and attach your photo.

By ID Photo Booth (compatible models only)

Take a photo at the photo booth, read the QR code of the individual number card issuance application form, and enter the necessary information.

An ID photo booth is installed on the 1st floor of the City Hall. Please use it to apply.

If you do not have the application form or there is a change in the application form sent together with the notification card, new forms are distributed at the Citizens' Affairs Section. Please bring your identification card such as a driver's license to the window.

Reception Procedure

The City Hall will send you an issuance notification letter approximately one month after the application. Bring this letter to the City Hall. It is mandatory for the bearer to come in person. Upon receipt, a personal identification card such as a driver's license is required.

WHEN YOU REACH THE AGE OF 20 YEARS, YOU ARE SUPPOSED TO PARTICIPATE IN THE "NATIONAL PENSION" (20歳になったら国民年金の加入手続きを)

All people who live in Japan and who are more than 20 years old and less than 60 years old are supposed to join the National Pension Scheme and pay its premium (except members of Welfare Pension or Mutual Aid Association).

In the National Pension, there is an "old age basic pension" which can be given to persons from the age of 65 years old, "injury basic pension" which can be given to injured or ill persons, "survivor's basic pension" which is given to a spouse and/or children when a member dies, etc. Those pensions are the system that everyone pays a premium for, ensuring mutual help to maintain stable lives. The public pension system guarantees payment for a life, demonstrates the country's responsibility for its citizens, and provides stable management.

When you become 20 years old, join the national pension.

Application to postpone or exempt premium payment

If you delay your participation or forget payment of the premiums, you will not be able to receive the injury pension or survivor's basic pension.

If your income decreases or you become unemployed and you can't pay the premium, you can apply to postpone or exempt your premium payment. Japan Pension Service examines the application and decides whether you can have the whole amount or a partial amount "exempt", or if you can "postpone" the premium payment.

The examination is made for 25 months retroactive from the application date.

During an exemption or postponement period, the amount of the old age pension will be reduced. You can pay the exemption or postponement premium within 10 years, but payments of the premium more than 2 years after the deadline will incur an additional charge.

For National pension premium payments, bank account transfer is convenient

You won't forget to pay your premium if you pay by bank account transfer. If you pay in advance, there is a discount. For more details see National Pension Service website.

Application: Fill in a "National Pension premium bank account transfer application form", (available at Pension office, bank, City office *Hoken Nenkin-ka* or Insurance & Pension Section), and bring the form with your family seal registered to the bank marked on it to Funabashi Pension Office or to the bank.

- When you apply, please confirm the time limit. If you mail it, have a margin to ensure the form arrives within the time limit.
- * As for the transfer payment of a partial exemption premium, the transfer date is only at the end of the next month.

Subsidy for Thyroid Echocardiography and Whole Body Counter – Radiation Exposure

(甲状腺エコー検査、ホールボディカウンタ測定費用の一部助成)

In order to reduce anxiety about citizen's health with regard to the initial radiation exposure of Fukushima Daiichi Nuclear Power Plant accident, Shiroi City will subsidize a part of the payment for thyroid echocardiography and whole body counter. Please contact us for more details.

Thyroid Echocardiography

[Target]

People who were born between April 2, 1992 and April 1, 2011, and a registered Shiroi citizen on the day of the accident and examination.

[Subsidy Amount]

half amount of examination expense (maximum of 3,000 yen), households receiving livelihood protection in full (up to 6,000 yen)

Whole Body Counter

[Target]

People who are pregnant, considerably below third-year high school, and a registered Shiroi citizen on the examination day.

[Subsidy Amount]

a partial amount of examination fee (maximum of 3,000yen), households receiving livelihood protection in full (up to 6,000yen).

If it is difficult for infants to take the test, their guardians can take it on their behalf instead. The application deadline for both subsidies will be within one year from the date you paid the expenses. If you have already taken the test, please apply as soon as possible.

Review of bulk garbage disposal fee (粗大ごみ処理手数料の見直し)

Regarding bulk garbage disposal, there is actually a big difference between the processing expenses and the disposal fees shouldered by citizens. We asked the "Waste Weight Reduction Promotion Council" for a review of the bulk garbage disposal handling fees in October and the report is as follows.

Based on this report, the revised fee is scheduled to be effective on January 1, 2020.

Report content: Based on the usage fee and handling fee, the current fee is revised to about 1.5 times. The fee is revised for each item, and for bulky ones not on the list of items, they are revised as follows.

Periodic Pneumococcal Vaccination of the Elderly

~ The vaccination period for 2018 is until March 31 ~

(高齢者肺炎球菌の定期予防接種~平成30年度接種対象の期限は3月31日までです~)

Pneumonia is the third leading cause of death in Japan. A quarter to one-third of pneumonia among adults is considered to be caused by Streptococcus pneumoniae. This pneumococcus is bacteria mainly contained in the secretions of the respiratory tract and can be infected through saliva and the like, which can cause heavy complications such as bronchitis, pneumonia, and sepsis.

In the city, we regularly perform pneumococcal vaccination. It is given once per person at a target age.

Those who did not get vaccinated at your target age and those who got the elderly pneumococcal vaccine (Pneumovax) in the past are not eligible, so be careful. Target

- ① People who are 65 years old, 70 years old, 75 years old, 80 years old, 85 years old, 90 years old, 95 years old, and 100 years old in 2018
- ② Person who is over 60 years old and under 65 years old, and has heart, kidney or respiratory problems, or possessing Physically Handicapped Personal Handbook 1 due to impairment of immune function by the human immunodeficiency virus

FY 2019 Registrations start for groups to use school sport facilities

へいせい ねんどがっこうたいいくしせつ ていきりょうだんたいぜんきとうろく (平成31年度学校体育施設の定期利用団体前期登録スタート)

Groups need to register if they regularly use elementary or junior high school sport facilities. Please note that registration does not guarantee that you can use those facilities whenever you want to use them.

It is prohibited to make profits from using those facilities.

Sport facilities:

[Elementary, junior high school] ground, gym, judo, kendo, kyudo gym, tennis court

* Children's hardball baseball and adult baseball are not allowed.

Futsal is not allowed in gyms. Kyudo gyms can only be used by persons who have experience in Kyudo.

Use period: April 1st (Mon) 2019 ~ Mar 31st (Tue) 2020

Groups: consisting of more than 10 people who live or work in Shiroi, that attended the guidance for the group users of school sports facilities open services for FY2019 (the announcement for the guidance was made ion Shiroi Bulletin January 1st). If you didn't attend the guidance and want to use the facilities, please come and talk to Shogai gakushu-ka or Lifelong Learning Section.

* There should be a person in charge of management (an adult) when using school facilities. Charges (an electricity charge): 140 yen per hour for gyms, 70 yen per hour for judo gyms.
