Holiday of February - 2/11 Kenkokukinen no Hi (National Foundation Day)

In 1873, the Meiji government designated Feb 11 as Empire Day based on the myth that the first emperor, Emperor Jinmu took the throne on Feb 11, 660BC. The Empire Day was abolished under the GHQ order on 1948, but later National Foundation Day was introduced on 1966.

DECLARATION FOR 2017 YEAR OF CITY/PREFECTURAL TAXES, AND FINAL RETURNS FOR INCOME TAX

(平成29年分「市民税・県民税の申告」と「所得税の確定申告」)

Shiroi city will conduct the "Acceptance of Declaration", "Guidance of Self-Writing/Individual Consultation" and "Free Consultation by the Tax Accountant Society" from February 16 (Fri) until March 15 (Thu).

Those who need to declare

Citizens living in Shiroi (on Jan. 1st, 2018) and corresponding to one of the following conditions during the year of 2017.

[City/Prefectural Tax]

- Those who received employment income only, but their employer has not reported the payment statement (a certificate of tax deducted) to the Shiroi City Office.
- Those who don't need to make a declaration of income tax, but who would like to claim various deductions such as a life insurance premium, etc.
- Those who received a handicapped person's pension or survivor's pension, but received no other income.
- Those who had no income and were not anyone's dependent.
- Those who are dependent on a relative who is a tax payer living in another city.

X People are still required to submit a city/prefectural resident tax declaration if they have an income.

[Income Tax]

Make sure to keep "copied receipts" for large amounts of medical expenses

「領収書のコピー」を)

If you paid a large amount (where the monthly total amount exceeds a family's fixed limit) for the city's National Health Insurance, the city will make a refund for 'large medical expenses' upon your application. For the application procedure, a receipt (or copy) of medical expenses must be attached. Take care when applying for a tax declaration. When the paid amount is not confirmed from the receipt (or copy), you may not receive a refund for 'large medical expenses'.

The city will notify a corresponding person as to the refund procedure two or three months after the medical consultation. For example: the city's notification will be sent at the end of January for a consultation in November; in February, for consultations at the end of December.

♦ Persons who have business income or real estate income:

Those who received the whole amount of their income in 2017, which exceeded their total income deductions for items such as basic deductions and dependent deductions, etc.

Persons who are not required to submit an income tax declaration, are still required to submit a city/prefectural resident tax declaration.

Persons who received an employment income:

- Those who received an employment income exceeding 20 million yen
- Those who received more than 200 thousand yen of private income other than employment income
- Those who received incomes from more than two different employers
- Those who had income tax withheld, want an income tax refund for medical bill deductions and/or housing loan deductions, etc.
- Those who retired in 2017, and had no year-end tax adjustment

[Notice from Narita Tax Office]

Writing a declaration form and submission

Narita Tax Office (*Narita Zeimusho*) will open a meeting place to write and submit 2017 taxes for income, special restoration, consumption of private business, local consumption, and donations. However, consultation of inheritance tax, payment of the state tax, and application and issue of paid tax certificates will not be conducted.

Narita tax office will not provide an open writing space.

Date: Week-days on February 13 (Tue) – March 15 (Thu), February 18 (Sun), and 25 (Sun). 9:00 am ~ 4:00 pm (Applications of declaration will be accepted until 5:00 p.m.)

Venue: Aeon Hall at 2nd floor Narita Aeon Mall

♦ Persons who made a donation to their hometown and require a donation deduction;

Persons who made a donation to more than six groups from January 1 till December 31, 2017

* Those who made a donation to 5 groups or less, and who received an employment income that does not require an income tax declarationcan receive a tax deduction by submitting "a special application" to the government detailing the donations made.

[Pensioners do not need to make a declaration]

Among pensioners, those who received a public pension income of less than 4 million yen, and received less than 200 thousand yen of other income, are not required to make a final declaration of income tax, but may submit an application for the final income tax return.

Persons who don't need to declare their income tax, who want to receive a deduction of life insurance premiums, etc. which are not listed on "the tax deduction certificate", are requested to declare the city/prefectural resident tax.

Things to bring for declaration

- · My-number card, a notice card, or a document with My-number written and a driver's license (the copy needs to be attached)
- · Inkan or Seal, writing materials, a calculator
- Document showing a whole income for 2017 (salary payment or certificate of tax deducted at source for pension, etc.)
- · Your account numbers for your financial institution (bank or post office)
- The copy of FY2016 declaration that shows the amount of deduction
- · A document, etc. that shows a deducted amount, such as the following:
 - > Certificate which shows deduction for premium on National Pension, or a copy of payment receipt
 - Receipt which shows the amount paid such as National health insurance premium, Nursing care premium, Medical insurance premium for senior citizens
 - > Deduction certificate for a premium for life insurance or earthquake insurance
 - ➤ A receipt of medical expenses
 - ➤ A copy of physically handicapped book
 - ➤ A document for spouse's income amount

If a person doesn't have a physically handicapped note, if he/she is 65 years old or over, and has been approved as

requiring necessary support care, he/she may be considered as a person who is a deducted person, and is encouraged to consult *Koreisha Fukushi-ka* or the Elderly Welfare Section. Tel 497-3473

A document necessary to declare the special deduction for housing loan for the first time

- · A detailed statement of housing loan special deduction
- Certificate of yearend balance
- · Document of house and land sales contract
- · House and land registration certificate

"e-Tax" will be easy to make a declaration

Please visit the National Tax Agency's homepage. You can make a declaration 24 hours a day during the application period, and will receive your tax return earlier. By filling in the form of receipt and salary payment or certificate of tax deducted online, you don't need to submit the original forms/certificates. (The necessary documents should be kept for 5 years in case they are required to be shown later)

* "Electronic certificate" or "IC card Reader/Writer" are necessary to make a declaration by e-Tax.

Notes;

- · If you prepare documents by personal computer (PC), staff will assist. Final documents may be submitted (or by mail)
- · Distribution of declaration documents will not be available.
- · City staff will assist self-writing, and the final documents may be submitted.
- As to 'Blue Return' declaration for income tax, transfer income, consumption tax, donation tax, etc, the city will
 only distribute the form.

"Medical expenses notice" can be used to declare a medical expenses deduction

According to the change of the law, a medical expenses notice can be used to declare medical expense deductions from Jan. 1st, 2018. When you make a declaration, attach the medical expenses notice from FY2017 declaration.

Please make sure the medical expenses notice can be used for the declaration.

City national medical insurance policyholders can use the notice for the declaration.

Medical expenses notice forms are different according to each insurer, and some notices may not be used for the declaration. Please confirm with the insurer. The notice of Chiba pref. senior citizens medical insurance cannot be used.

Matters of attention when using a medical expense notice for the declaration:

When you declare the expense that is not written on the notice, make a detailed statement with the receipt by yourself.

When your actual payment is not the same amount as the written one on the notice, you need to correct the expenses on the declaration.

Pay Taxes or Utilities via Direct Withdrawal~It will prevent you from forgetting to pay the bill and taxes~

What city taxes, utilities can be paid via direct withdrawal?

Fixed asset tax, City planning tax, Light vehicle tax, Municipal and Prefectural tax (general collection), National health insurance, Late elderly medical insurance, Long term care insurance premiums, Nursing-care insurance premiums, Child care division, Fee for child day care for Gakudo-Hoiku

* Direct withdrawal is not available in case there is another term of payment due date required by the city besides the normal due date.

Which banks are available for the direct withdrawal?

◆How to apply

Complete the "bank transfer request form" which will come with your tax notice or you'll find it in every bank in the city. Please bring it to the bank where you have your account 2 months before the month you want your tax or utilities withdrawn.

◆Things you need

Bank transfer request form (or Payment with automatic debit request form if the bank you use is Yucho-bank), the newest tax notice, your passbook and Hanko for the bank.

FY 2018 Registration for groups to use school sport facilities starts

へいせい ねんどがっこうたいいくしせつ ていきりょうだんたいぜんき (平成29年度学校体育施設の定期利用団体前期 とうろく 登録スタート)

Groups need to register if they regularly use elementary or junior high school sport facilities. The registration doesn't always guarantee that you can use those facilities whenever you want to use them regularly.

It is prohibited to make profits from using those facilities.

Sport facilities:

[Elementary, junior high school] ground, gym, judo, kendo, kyudo gym, tennis court

* Children's hardball baseball and adult baseball are not allowed.

Futsal is not allowed in gyms. Kyudo gyms is allowed to be played only by persons who have experience in Kyudo.

Use period: April 1st (Sun) ~ Mar 31st (Sat) 2019 The durations for the use of the facilities will be one year from this March.

Groups: consisting of more than 10 people who live or work in Shiroi.

X There should be a person in charge of management (an adult) when using school facilities.

Charges (an electricity charge): 140 yen per hour for gyms, 70 yen per hour for judo gyms. Kyudo gym: actual cost

The City and UR (Urban Renaissance Agency) Support People Who Live Near or With Their Family

Shioi-city \(\subsidies \) for living near or together with elderly parents \(\)

If you moved to the city from another city for the purpose of living near or together with your elderly parents after April 1st, 2016, the city will give you subsidies for the expenses to purchase a house or make home renovations.

Subsidies for living near or together with elderly parents

Target people: Anyone who falls into the category below (first come first served)

- · Applicants or the spouse of the applicant must be a transferred citizens (included unmarried person)
- The age of the applicant or the spouse of the applicant must be under 49 years on the day they moved to the city.
- · Either of your parents must have more than five year records of living in the city on their resident's card.
- There must be no delinquency in the city tax payment among your family member (this does not include persons younger than 18 years)
- · It must be that no family members have taken these subsidies so far.
- The renovated house must belong to you, your spouse, your parents or your spouse's parents.
- The newly built or purchased or extended house must be registered.
- · You must live in the newly built, purchased, extended or renovated house and renew your resident's card.
- * The application is available for one year since you moved to the city.

UR(Urban Renaissance Agency) "Discount for the rent for people living near elderly parents, "WIDE Discount" Relatives within the third degree of relationship who are either parent household or child household can be eligible for this discount.

The discount rate

- You will get 5% of the discount from your rent for the UR apartment for the first 5years.
- You will get 20% of the discount for the first 5 years if the monthly household income is less than ¥259,000.

Facility Charges and Service Fees will be Revised from April 1st

(4月1日から使用料、利用料金、手数料の一部を改定します)

Shiroi city is conducting a review of facility charges and service fees from April $1^{\rm st}$, in regard of fair burden sharing between actual users of facilities and others. Such charges and fees have been maintained from 2006, which has caused a gap between the charges/fees and actual costs. So the City will revise charges/fees to fill this gap. This revision will go into effect on April $1^{\rm st}$ (City Bicycle Park charge will be revised from July $1^{\rm st}$.)

Currently, daytime charges and nighttime charges differ but this difference will be removed because the actual cost is the same.
