DECLARATION FOR CITY/PREFECTURAL TAXES AND FINAL RETURNS FOR INCOME TAX — TO BE ACCEPTED FROM MONDAY FEB. 16 TILL MONDAY **MAR. 16**

(市・県民税の申告と所得税の確定申告、2月16日から3月16日まで受け付け)

Starting February 16 (Monday) through to 27 (Friday), individual consultations will be conducted for declarations of the city/prefectural resident taxes for 2014. The consulting order starts at 8:30 a.m. on a first come first served basis.

Special deductions for housing loans or medical expenses etc., and declarations of the final return for income tax will also be accepted during this free consultation or self-writing period.

Early applications for income tax returns are preferable. (More details are shown below.)

♦ Those who must submit a declaration

Declarations for city/prefectural tax or income tax returns are required from those who are registered as a resident in Shiroi city as of January 1, 2015, and who correspond to one of the following conditions during the year of 2014:

[For the city and prefectural resident's taxes]

- Those who received employment income only but their employer has not reported the pay statement (a certificate of tax deducted) to the Shiroi city office.
- Those who don't need to make a declaration of income tax, but who would like to claim various deductions such as life insurance premium, etc.
- Those who received a handicapped person's pension or survivor's pension, but received no other income.
- Those who had no income and did not belong to anyone's dependent.
- Those who are dependent on a relative who is a tax payer living in another city.

* The declaration of city/prefectural tax is required as long as they have an income.

[For income tax]

Persons who have business or real estate income:

- Those who received the whole amount of their income in 2014, which exceeded their total income deductions for items such as basic deductions and dependent deductions, etc.
- * People who are not required to submit an income tax declaration, are still required to submit a city/prefectural resident tax declaration.

Persons who received an employment income:

- Those who received an employment income exceeding 20 million yen.
- Those who received more than 200 thousand yen of private income other than employment income.
- Those who received incomes from more than two different employers.
- Those who had income tax withheld but want an income tax refund for medical bill deductions and/or housing loan deductions, etc.
- Those who retired in 2014, and had no year-end tax adjustment.

♦Self-writing Guidance Class

Each person is required, as a rule, to prepare his or her declaration papers his or herself. The city will offer self-writing guidance, where staff will be available to assist residents in answering questions during individual consultations in the city hall. Those who would like to consult individually with city staff are requested in advance to prepare the necessary papers, such as income amounts, necessary expenses and various deductions. Farmers and business operators are requested in advance to prepare a detailed balance sheet before coming to the city hall.

During this period, completed declaration papers will be accepted.

♦ Pensioners do not need to make a declaration

Pensioners who received a public pension income of less than 4 million yen, and received less than 200 thousand yen of other income, are not required to make a final declaration of income tax, but may submit an application for the final income tax refund.

Persons who don't need to declare their income tax, but who want to receive a deduction of life insurance premiums, etc. which are not listed on "the tax deduction certificate", are requested to declare the city/prefecture resident tax.

♦E-tax declaration is convenient

The National Tax Authority is encouraging use of the E-tax declaration system by P.C. There is a homepage corner to make a convenient final declaration, etc.

The E-tax system includes an initial registration, making a series of declarations, and transmission of the declaration.

A declaration paper made in "a final tax return corner" may be printed, and transmitted directly to the tax office, which is an easy and convenient way for making a declaration.

Its schedules and necessary documents are available on the city homepage or contact directly to the city's *Kazei-ka* or Taxation Section.

Shiroi city will not handle writing or consultation as to declaration of 'a blue return', consumption tax, donation tax, transfer income of stocks or property, etc. but will accept such declaration documents.

Applications for income tax returns are available only for those whose income tax was already subtracted from the salary payment etc.

EARLY APPLICATION FOR INCOME TAX RETURNS IS PREFERABLE

(所得税の還付申告は早めに)

Eligible people who may apply for a refund

An employment income earner may apply for a refund as follows:

[Special deduction of housing loan etc.]

Those who bought a new or used house, or an old house that was renovated with funding from a housing loan, and who meet the following requirements, may get a special deduction for their housing loan etc.

For a new or renovated house: following ① to ⑤

For a used house: following ① to ⑥

- ① He/she moved into a house within six months after purchase, and is still living in the house.
- ② His/her total annual income is less than thirty million yen.
- ③ The term of the loan repayment is more than ten years, payment is via monthly installments, and the year-end balance still remains at the end of 2014.
- ④ A house has floor space of more than 50m², and more than a half of the floor space is for the exclusive use of living.
- ⑤ He/she doesn't receive any special exemption for a property transference income before and after two years of the occupancy.
- ⑥ The house before its purchase had been built within 20 years (within 25 years in the case of the fire-proof building)

[Deduction of medical expenses]

If medical expenses were paid for yourself and/or your family due to illness or injury, an income tax deduction will be granted at a certain amount.

Amount of deduction: Medical expenses paid in 2014 minus an amount covered by insurance, and minus a further 100,000 yen (in case the total income is less than two million yen, 5% of the income) (up to the maximum amount of 2 million yen)

◆Free consultation/self-writing guidance

The city's assistants together with members of licensed tax accountant associations will help write a declaration form by PC free of charge and submit it, and provide "self-writing guidance" at the city

office. On these days you may also submit the declaration form that you have already prepared. On these free consultations, the first year of the income from property transference or housing loan special deduction will not be handled by the association for licensed tax accountants.

* The city only provides declaration forms for blue return, income from property transference, consumption tax, donation tax, etc (i.e. it does not provide consultations). For further details refer to the "Narita Tax Office's notice".

A document available on Social Insurances for Declaration of Tax Deduction, etc.

(確定申告などの社会保険控除の資料に利用できます)

The city sent "a notice of the paid receipt" during the year of 2014 to tax payers by postal card at the end of January for the National Health Insurance tax, premiums of the senior medical insurance (75 years or older), and nursing care insurance.

Please use the notice for the deduction of social insurance when you apply for an income tax return or declaration of the city/prefectural tax for the year of 2014.

* The above notice excludes the amount drawn by "special collection from the pension".

Please refer to the amount drawn from the pension to "certificate of tax deduction for public pension etc." issued by the pension payer.

Make sure to keep copies of receipts for large amounts of medical expenses

こうがく いりょうひ ふたん ひと りょうしゅうしょ かなら (高額な医療費を負担した人は領 収 書のコピーを 必 ずとっておきましょう)

If you paid a large amount (monthly total amount exceeds a family's fixed limit) of the city's National Health Insurance, the city will later make a refund as 'large medical expense' upon payer's application.

For the application procedure, receipts (or copies) of medical expenses must be attached. Be careful of applications for a tax declaration.

When the paid amount is not confirmed from the receipts (or copies), you may not receive a refund for the large medical expense.

The city will notify the corresponding person two or three month after the medical consultation. For example: the city's notification will be sent at the end of January for consultations held in November; at the end of February, for consultations held in December.

Necessary items for the application of declaration for City/Prefectural Resident and Income Tax

Returns (確定申告に必要なもの)

Necessary items are *inkan* or seal, writing tools, calculating machine, papers to show income amount in 2014 FY (*Gensen Choshu-hyo* or tax deduction certificate), bank account number of the tax recipient, and necessary documents to show the amount of deduction.

Documents to show the amount of deduction: deduction certificate for National pension premium, and receipt if any other than certificate. Receipt for National health insurance tax, nursing care and senior medical insurance. Deduction certificate for premium of life or earthquake insurance, and spouse income certificate and so on.

- * If you are classified as someone in need of support or care, and 65 years of age or older, you may be certified for the same deduction as a handicapped person. Please contact Senior Welfare Section (*Koureisha fukushi-ka*).
- Please see what you need to bring for the declaration in the following table.

THE INDIVIDUAL ACCIDENT OF CITY CIRCLE BUS 'NASHI-GO'
