Have you applied for temporary special benefits for single-parent households?

(ひとり親世帯臨時特別給付金の申請はお済みですか?)

As an economic measure againstCOVID-19, the deadline for applying for benefits for single-parent households (including caregivers) who are responsible for child-rearing and work alone is approaching.

Basic benefits:

Target: Single-parent households that fall under any of the following

- 1. Households paid child support allowance for June 2020.
- 2. Households whose income in the previous year is less than the child-rearing allowance payment limit, but who are not paid child-rearing allowance due to receiving a public pension, etc. (regardless of application)
- Households whose household income has changed suddenly due to the influence of COVID-19 and whose latest income is at the level of receiving child-rearing allowance.

Benefit: ¥50,000 (additional ¥30,000 per child after the second child)

Additional benefits: In households that fall under 1 and 2 above, if the household budget changes suddenly due to the effects of COVID-19 and income is greatly reduced, an additional 50,000 yen will be paid.

Re-payment of basic benefits:

The same amount as the basic benefit is paid to the basic benefit applicant

Application procedures for payment:

By Friday, February 26, 2021, fill out the application form (located on the city website or at the section in charge) and attach the necessary documents (located on the city homepage or at the section in charge) to the Child Care Support Division.

The filing of city and prefectural tax, and final income tax return will be accepted from February 16 (Tue) through March 15 (Mon).

Shiroi city will accept the submission of the filing of the deduction for medical expense and special deduction for housing loans, etc. The city also will hold "Free consultations by tax accountants and city staff", etc. and accept attendants for the meetings. The forms of filing will be distributed at the city hall and its branches late in January.

Those who need to file

Citizens living in Shiroi (as of January 1, 2021) who fall under any one of the following conditions during FY 2020.

City and Prefectural tax:

- Those who received employment income only.
 Their employer has not submitted a payment record of salary (certificate of income and withholding tax) to the city.
- Those who don't need to file a final tax return but want to receive life insurance deduction and other deductions.
- Those who received a disability pension or survivor's pension but received no other income.
- Those who had no income and were not anyone's dependent.
- Those who are dependent on a relative who is a tax payer living in another city.
- The spouse living with those whose income is over 10 million yen, The income of the spouse is under 480.000 yen.
- * Residents are required to file city and prefectural taxes if they have income regardless of the amount of income.

Income tax:

Persons who have business income or real estate income:

Persons whose total income exceeds the total amount of deduction from

income such as, basic deduction, deduction for dependents, etc.

* Filing of city and prefectural taxes is required even when it is not necessary to file an income tax return.

Persons who received employment income:

- Those who received employment income exceeding 20 million yen.
- Those whose income exceeded 200 thousand yen excluding employment income.
- Those who received employment income from more than two employers.
- Those who had income tax withheld and want an income tax refund for medical expenses deductions and/or housing loan deductions, etc.
- Those who retired in FY 2020 and had no year-end tax adjustment.

Persons who made a donation to their hometown and are filing a donation deduction:

Persons who made donation(s) to their home town between January 1 and December 31, 2020.

* Those who made donations to six (6) groups or more need to file the deduction for all of the donations in their final tax return. Those who file deduction(s) for medical expenses in the final tax return also need to file the donation deduction in their final tax return even if one stop exception is applied to them.

Documents necessary for filing tax return (Proof of income)

- 1. Certificate of employment and pension income, etc., and withholding tax.
- 2. Payment record of remuneration (Other income than ① above)

(Proof of the amount of deduction)

- 3. Payment record of insurance premium (National Health Insurance, Life insurance, Earthquake insurance, etc.)
- 4. Details of medical expense deductions and Self-medication tax
- Receipt of National Health Insurance tax, Long-term Care Insurance premium, premium for the Medical System for the Elderly, etc.
- 6. Disability certificate (Those who receive disability deduction)

- * Those who are over 65 years old and certified as requiring long-term care may be the target of deduction if they don't have a disability certificate. Please consult with Elderly Welfare Section. Tel. 047-497-3484.
- 7. Receipt or certificate of receipt of donation. **(Others)**
- 8. Any one of My Number Card or Notice card with ID (driver's license, etc.).
- * If you file the final tax return to the city, a copy of each document is necessary.
- 9. Seal, Writing materials, Calculator.
- 10. Proof to show the bank account.
- 11. Copy of ID and password (those who use e-Tax)
- * Those who filed a final tax return last year need the copy of the file and the amount of deduction.

(Special deduction for housing loan, etc. which is applicable after the second year)

- 12. Calculation sheet (green color) that is sent from a tax office.
- 13. Balance certificate of the loan at the end of the year.
- * Please consult the deduction for extension and renovation of the house with the Narita Tax Office.

Pension recipients do not need to file final tax return

The following pension recipients do not need to file a final tax return; Annual pension income is less than 4 million yen and the income other than the miscellaneous income related to the pension is less than 200 thousand yen.

However, it is necessary to submit a final tax return to receive a tax return of income. It is necessary to file the city and prefectural tax if a person wants to receive the deduction for life insurance premium, etc. that are not stated in the certificate of income and withholding tax for public pension, etc.

Please use e-Tax to file final tax return

It is by e-Tax in principle to file the final tax return at the venue of the city for the preparation of documents. At the venue, you can register your ID and password, complete your final tax return form and send it.

* You will need a password. Please prepare your password that is made of between 8 to 50 characters and includes both English lowercase and numerals.

You no longer need to attach receipt for the medical expense deduction

From the final tax return for FY 2017, it became mandatory to attach a "**statement of details**" instead of receipt. Please be sure to prepare a statement of details if you want the medical expenses deduction.

- * You need to keep the receipts of medical expenses for 5 years.
- * If you attach the notice of medical expenses issued by a medical insurance institute, you don't need to attach the statement of details (Some notices are not good for this purpose. So, please confirm with the insurer if it is good or not.). If there is any discrepancy between the actual co-payment and the deductibles stated in the notice, the amount of actual co-payment prevails.

At the free consultation (Tax Accountant Association), assistants will help you complete the tax return form. You can submit the tax return form for income tax and reconstruction income tax of a small size tax payer, consumption tax for individuals, and the income tax and reconstruction special consumption tax of pension recipient and salaried workers. (However, if you want the special deduction for the housing loan, etc. (first year) or you have capital gains, you cannot submit your tax return at the venue.)

- * We only distribute tax return forms to persons who want to consult at the venue.
- * If you do not need to consult, please submit the tax return by mail or bring it to a tax office.

At the consultation with city staff, city staff will input the tax return into a PC prepared for e-Tax and finally accept the tax return form after completion.

Following matters will not be accepted for consultation this time.

- Special deduction for housing loan, etc. (We will accept a consultation if the deduction is after the second year, and there are calculation sheets sent from a tax office (blue color) and the balance certificate of the loan at the end of the year sent from a financial institution.)
- Business income, agriculture income and real estate income (We will accept a consultation if Income and Expenditure Breakdown is completed or if the copy of the Income and Expenditure Breakdown of the previous year is brought in, the account book, etc. are completed and the content of consultation is only to copy the amount.)
- 3. Deduction for miscellaneous loss
- 4. Filing of the tax return for past year(s)
- 5. Semi-final tax return
- Others. For example, when it will take considerable time because the preparation for completing the form is deficient.

* Regarding the following forms, only submission will be accepted and consultations are not accepted; Separate taxation (retirement income, capital gains, dividend income, etc.), blue declaration of income, consumption tax, gift tax, and inheritance tax.

Narita tax office will open a venue for the writing and submission of tax return forms

A venue will be prepared for the writing and submission of the following final tax returns for FY 2020; income tax, gift tax and individual consumption tax. During the period that the venue is open, there will be no place in the Narita tax office for the writing and consultation of final tax returns.

* In the venue, the following services are not available; consultation of inheritance tax, payment of national tax, issuance of payment certificate of tax, browsing of forms and disclosure of forms.

Date: Week day of February 1 (Mon) ~ March 15 (Mon), February 21 (Sun) and 28 (Sun).

Reception: 9:00 a.m.~ 4:00 p.m. (Submission is accepted till 5:00 p.m.)

Place: Aeon Mall Narita 2F, Aeon hall.

To enter the venue, an admission ticket is necessary to mitigate congestion. The reception may be closed early depending on the distribution situation of admission tickets. Admission tickets are distributed on the day at the venue. You can get a ticket in advance using the ON LINE application.

Let's use Generic Drugs (ジェネリック医薬品を利用しましょう)

Generic drugs are drugs which are produced after the patent for the original drug has expired. Generic drugs are as effective and safe as the drugs produced before the expiration of patent and are certified by the Ministry of Health, Labor and Welfare.

Generic drugs need lower development costs and the price is reasonable. Use of generic

drugs reduces your medical costs and your burden as well.

There are some cases where no generic drug is available or your burden does not reduce after switching to generic drug. Please consult a doctor or pharmacist when you get a prescription.

Notice of Education Support System

(教育支援制度のお知らせ)

School attendance support system

The city renders assistance for school expenses to the family of children and students who have difficulty in attending elementary or junior high school due to economic reasons.

Target: Persons who live in the city and are guardians of the children and students who attend the Shiroi city's municipal elementary schools or junior high schools (Children and students scheduled to enter such schools are included.). The target persons need to satisfy any one of the following conditions;

- 1. Protected persons as stipulated in the Public Assistance Act, article 6, paragraph 2.
- 2. Persons who received any one of the following measures and are certified by the city's Education Committee as equivalent to the persons as said in ① above.
 - Suspension or abolition of assistance based on the Public Assistance Act.
 - Reduction or exemption of personal business tax, property tax or municipal tax based on the Local Tax Law, etc.
 - Reduction or exemption of national pension premium based on the National Pension Law.
 - Reduction or exemption of National Health Insurance Tax based on the National Health Insurance Law.
 - Receipt of child-rearing allowance based on the Child Rearing Allowance Law.
 - Receipt of loan based on the Living Welfare Fund System.
- Persons who do not satisfy any one of the above conditions may be a target if they are in

economic difficulty due to unemployment,

- * disease, unexpected accident, disaster, etc. **Contents of support:** School supplies, Expenses to go to school, Off-campus activity expenses, School excursion expenses, School supplies for newly enrolled children and students, etc., Medical expenses, School lunch fee.
- * Protected persons identified in ① above are eligible only for excursion expenses and medical expenses.

School attendance encouragement system

The city will subsidize part of the necessary school expenses depending on the income of the household to reduce the economic burden. The target is guardians who have children attending individual support classes in the municipal elementary and junior high schools or disabled children (equivalent to the children stipulated in article 22- 3 of the School Education Law Enforcement Ordinance) attending ordinary classes in municipal elementary and junior high schools. For more details, please refer to the home page of Shiroi city.

Contents of support: Part of School supplies, Off-campus activity expenses, School excursion expenses, Expenses for going to school, School lunch fee, etc.

* We will distribute necessary documents to guardians through schools in the beginning of June.

◆ Definition of family doctor

The doctor is reliable and lives near your home. You can consult your family doctor about everything to do with your health and if necessary, be introduced to medical institutions specializing in the disease that you may have.

- So, there are many merits for having a family doctor!
- 1. You can take the necessary measures at an early stage of your ailment because you know the daily conditions of your health.

- 2. Your family doctor will introduce you to the right specialist(s) if necessary.
- 3. You can feel free to consult your family doctor at any time about everything to do with your health. This helps you prevent diseases from becoming serious without skipping or postponing medical checks or taking wrong measures.

When you have a fever and/or cough and doubt infection of COVID-19, please consult with the home doctor by phone before receiving diagnosis.

Periodic Pneumococcal Vaccination for the Elderly The vaccination period for FY 2020 is until March 31

こうれいしゃはいえんきゅうきん ていきょぼうせっしゅ れいわ ねんどせっしゅたいしら きげん がっ にち (高齢者肺炎球菌の定期予防接種:令和2年度接種対象の期限は3月31日まで)

A quarter to one-third of pneumonia among adults is considered to be caused by Streptococcus pneumoniae. Especially, it becomes serious among elderly people. This pneumococcus is the bacteria mainly contained in the secretions of the respiratory tract and can be infected through saliva and the like. It can cause heavy complications such as, bronchitis, pneumonia and sepsis.

In the city, we regularly perform pneumococcal vaccinations. It is given only once per person at a target age. Please be careful that those who have got the vaccination at a target age are not eligible.

Target:

- ① Persons who become 65, 70, 75, 80, 85, 90, 95, and 100 years old in FY 2020 (until March 31, 2021)
- ② Persons who are over 60 and under 65 years old, and have any one of heart, kidney, or respiratory problems or immune dysfunction caused by human immunodeficiency virus (HIV) and persons who possess the Physically Handicapped Personal Handbook grade 1.

Period: Until March 31, 2021

Recommended recipe with plenty of vegetables

Refreshing salad with turnip and kumquat

(かぶときんかんのさわやかサラダ)

Ingredients: (For 2 people)

Turnip: 2 pcs. (240g),

Salt: a little, Kumquat: 2 pcs,

A (Vinegar: 1 tablespoon, Olive oil: 2 teaspoons,

Honey: 1 teaspoon, Salt: 1/4 teaspoon)

Recipe:

- Slice turnip thinly with skin into the shape of a ginkgo leaf. Cut the leaf of turnip into 1 cm pieces. Put a little salt on the leaf and leave it for a while. When the leaves become soft, squeeze out the water.
- 2. Cut kumquats into half, take out seeds and slice them.
- 3. Mix the ingredients A and add 1 and 2



A word from a registered dietitian

This recipe makes use of the fresh sourness of kumquats and the sweetness of turnips. Do you know? The leaves of turnips contain 5 times the of calcium compared to spinach. It is mottai nai (too good) to throw away the leaves of turnips. Let's use the leaves of turnips when they are fresh. It is also good for miso soup or stir-fries.

For 1 person: 86 Kcal, Salt equivalent: 0.8g Volume of vegetables: 120g (350g is the target

volume of vegetables per day)

Cooking time: 15 min

How are you? I'm a city public Health Nurse (お元気ですか 保健師です)

Child Care Coordinator (子育てコーディネーター)

The days are cold. How are you? We hope you are doing well.

As a public health nurse, I receive consultations every day about child care. You may have doubts or concerns about child care before your children enters elementary school, such as, "Can I ask such matters?", "Who should I consult with?" or "Am I doing the right things with parenting?".

Shiroi city opened branches of the Comprehensive Child Care Assistance Center in Child Care Support Section, Health Section and Nursery Section. The objective is to join related sections in providing assistance to families raising children. Child care coordinators have been assigned to the Child Care Support Section as the most important work of the center.

Child care coordinators will provide information to make it easy for the guardians of children or pregnant women to use the education and nursery facilities and regional child care assistance system. They also receive consultations and give advice etc. when necessary.

For example, they can answer questions about the place where children and parents can play together or about temporary child care facilities when parents need to attend a ceremony or their health condition is not good. Child care coordinators also accept other questions and if necessary, introduce other facilities to consult with. They think of the problem together with guardians and convey information to help them solve the problem.

Child care coordinators sit at the window of the Child Care Support Section. They also visit Comprehensive Child Care Assistance Center and families that need assistance for convenient consultation. Please feel free to consult with the coordinators.

Hi, Consumer Affairs Center!

Many accidents are occurring! Beware of troubles with portable stoves!

Question: I found lots of cylinders for my portable stove which I stocked in case of a disaster. I am not sure when I bought them but want to use them as is. Is it OK?

(Male in 60s)

Answer: Portable stoves are necessary for making casseroles at home. But don't use stocked cylinders if the date of production is not known or there is discoloration and /or rust on the metal part.

Followings are the important points to use cylinders safely;

Confirm the expiration date!

The expiration date is shown on the bottom of the cylinder, etc. Generally speaking, use of the cylinder within seven (7) years after production is required.

Some old cylinders do not show the production date and such cylinders should not be used.

◆ The expiration date of a portable stove is about the tenth (10th) year after production. Stoves produce their own risks if used for many years. Producer's association set a guideline of expiration date as "Ten years after production regardless of the frequency of use", taking into

account the natural wear down of rubber packaging

to prevent gas leaks.

Confirm how to use again

Mishandling may be the cause of a cylinder explosion, and fire and serious injury eventually. There was a case at a cherry-blossom viewing party where cylinders exploded because two stoves were put side by side and the cylinders over-heated. There is also the risk of an explosion if a stove is covered

with large kitchen wares or used for purposes other than cooking such as, firing of charcoal.

Many accidents are reported because of the incorrect use of the portable stoves. Please confirm the right way to use them again.

- ◆ Beware of how cylinders are stored! Take the cylinder out from the stove, put a cap on it and store it where it is below 40 degrees C with low humidity and no direct sunlight.
- How to dispose of a cylinder

Use up the gas in the cylinder and take it to your garbage collection point in a transparent bag. A hole on the bag is not necessary. Some producers have a take-over service for cylinders. You can check with them if your cylinder is still good or not.
